**A55 Junctions 15 and 16 Improvements  
Public Information Exhibitions**

Following last year's Public Consultation on options to improve Junctions 15 and 16, the Minister for Economy and Transport announced in April this year the preferred options. The project team have been developing these preferred options which are now developed in sufficient detail for public comment. Once the Welsh Government has collected this information the preferred options will then be developed further for the next stage; Statutory Process (Publication of draft Orders Highways Act, Acquisition of Land Act (Compulsory Purchase Order) and Environmental Statement).

Since your property is within the vicinity of one of the junctions, **I would like to invite you to attend the forthcoming Public Information Exhibitions**, where you can find out more about the options being developed. Members of the project team will be available at the exhibitions to answer your questions and explain the display material.
