18234 Ratification of the minutes of the meeting held on 3rd April 2018.

18241 Recruitment of Clerk

The advert was formally agreed by the HR committee at their meeting on Friday 13th April. Cllr Fisher advised that the HR committee should wait for Peninsula to compile a full job pack before advertising the post. All other aspects are in place. It was noted that the closing date for applications is 30th May 2018.

18242 Locum Clerk

Cllr Lloyd-Borland has spoken to a suitably qualified person who has expressed an interest in becoming the council's locum clerk; the person's CV was passed to the Mayor.

The Mayor informed that the town council's offer to CCBC (based on its own evaluation) was rejected. Both the Mayor and Deputy Mayor are to arrange a meeting with CCBC representative to see if terms could be reached and report back to full council.

18245 Penmaenan railings

Cllr Abbott has been in touch with CCBC regarding painting the railings but no painters can be allocated to it. Cllr Abbott has also proposed to CCBC that the Town Council source three quotes for painters.

18246 Project Sparkle

A quote of £840 has been received to paint a visual representation of the history of Penmaenmawr in the tunnels opposite the bowling green. Additional funding of £250 has been secured from North Wales Police to contribute toward the cost.

Cllr Lloyd-Borland stated that he would approach the building in question's owner and liaise with her directly. The Mayor stated that she would contact a local glazier to investigate other avenues of remedy.
